**PHRO CALL FOR ACTIVITY PLAN SUBMISSIONS ON:**

**HUMAN RIGHTS FOR WOMEN**

**Dead line: February 8<sup>th</sup>, 2010**

**A. Preamble**

The PHRO designed this "**Call for Activity Plan Submissions**" to open a competitive opportunity for previous beneficiaries from its trainings, particularly related to *NGOs Management, Planning and Fundraising*, to plan out an activity and submit it to the PHRO who will support one selected activity to be implemented on the occasion of **International Women's Day**. This is considered an incentive initiative and restricted to the participants (Centers/Organizations) who benefited from the workshops and the training course that were held within PHRO's project titled "**Strengthening Civil Society Structures: Empowering Women Programs Centers in the Palestinian Camps in Lebanon**" which was implemented in the period July 2009 – January 2010, with the kind support of the Embassy of Federal Republic of Germany in Lebanon through the Cooperation Program with the Lebanese Republic.

**B. Guidelines**

**This call is designed to support activity/ies that:**

- ✚ Promote knowledge, development, and exercises of human rights for women
- ✚ Protect and defend the rights of women
- ✚ Raise awareness of women's human rights
- ✚ Support and strengthen women's and other human rights focused organizations
- ✚ Develop the capacity of civil society organization in terms of working on human rights for women, gender equality and combating violence and discrimination against women

**Note:** Priority will be given to activity/ies which will be implemented in partnership with other civil society organizations/centers, particularly those who were participants in the trainings that were held under the above mentioned project.

**C. Area of focus: Palestinian Camps & Gatherings in Lebanon**

**D. Amount and Duration of Activity:**

- ❖ Proposed Activity/ies shouldn't exceed the total of **5,000 US-Dollars**.

- ❖ Activity/ies should preferably be of a one-month duration

#### E. Submitting the application

- ❖ Centers/Organizations must submit their applications to the relevant email address **by 5 pm (local time) on Monday, 8 February 2010.**
- ❖ The applicant Center/Organization must submit their completed **Application Form (Maximum of 5 pages)**, including a **Project Budget** calculated in US-Dollars.
- ❖ Applications must be **typed** and in **English**.
- ❖ Applications should be submitted by email to the relevant email address:

- ❖ Applicant centers/organizations must clearly save and name their Application Form, attachments and emails using the following pattern:
  1. Save the Application Form using this naming format:  
Organization name (or acronym), words 'Application Form'  
*Example: Organization ABC - Application Form*
  2. Save all attachments using this naming format:  
Organization name (or acronym), description of attachment  
*Example: ABC – Budget.*

#### F. Activities that are not Eligible for Funding

Support will not be provided for:

- ❖ Plans that contradict with human rights principles and standards
- ❖ Plans that support Political campaigns activities or political movements
- ❖ Emergency relief activities
- ❖ Projects or activities that create dependency
